- 1) CD Audiobook only (no audio cassettes included)
- 2) Includes RDA standards
- 3) Series and subject headings match the book record
- 4) Punctuation follows AACR2 rules, MARC bibliographic indicates acceptable punctuation rules
- 5) An On Order MARC record requires a 990 field with \$aON ORDER BRIEF RECORD
- 6) loc.gov Marc 21 is the definitive authority for making decisions

008 grid information populates to both the Leader field and the 008 field.

008 is the fixed fields. This field is comprised of 40 character positions. These fields are character position sensitive. In the 008 field, the character position starts with 0 NOT 1. These fields are important for searching in the catalog. As the character position is critical, the easiest way to input these fields will be to edit the “Fixed Fields” grid located at the top of the MARC record screen.

If typing in the 008 field (not the grid box), refer to <http://www.loc.gov/marc/bibliographic/bd008.html> for correct character positions.

Type: Type of record

i = non-musical sound recording

ELvl: Encoding Level

Use “7” unless it is either:

blank = the record is full-level—the most complete MARC record

or

a pipe “|” = the record is full-level input by OCLC participants.

Any other characters in the “ELvl” should be changed to “7”

Audn: Audience (right click for drop down menu)

a = preschool (0-5 years)

b = primary (6-8 years, K – 3rd grade)

c = pre-adolescent (9-13 years, 4th – 8th grade)

d = adolescent (14-17 years, 9th – 12th grade)

e = adult (18 and older)

Lang: Language (right click for drop down menu)

eng = English

Most material will be in English; materials published in different languages need to be coded appropriately.

Blvl: Bibliographic Level

m = monograph/Item

Form: Form of Item

Within the United States, use the 2 letter postal code and “u”

Desc: Descriptive Cataloging Form

i = follows RDA rules.

You need to have 040 \beng\$erda in your record

DtSt: Type of Date/Publication Status (right click for drop down menu)

s = single date

n = unknown date

Date 1: Only one date is used for an Audiobook record, so the DtSt would be “s” unless the date is unknown.

Date 2: blank

TrAr: Transposition and Arrangement

n = not applicable

Part: Music Parts

n = not applicable

LTxt: Literary Text for Sound Recordings (right click for drop down menu)

Type of literary text on spoken word sound recordings

If there is an existing audiobook record, with a different ISBN and/or publisher, it can be added to the existing record, so long as the number of discs, narrator, and duration of an audiobook is the same.

Add the 020 and/or 024 field with qualifying information and a note in the 590 field stating place of publication and publisher.

-ex: =590 \ \ \$aBooks on Tape edition published in Westminster, Md.

1st indicator = 1 for Universal Product Code (UPC)

2nd indicator = blank for no information provided

Add \$q for any qualifying information

1st indicator = 0 for Issue number

2nd indicator = 1 for Note, access point required

Publisher number can be taken from the container as well as the disc. If there is more than 1 number, use the \$q to indicate where the number was taken from. If there is a single number that is the same on the container and disc, there is no need to add qualifying information.

When importing from from Z39.50, delete all other subfields

1st indicator

0 = Forename with birth year

1 = Surname with birth and death year

-ex. 2: =100 1\ \$aTwain, Mark,\$d1835-1910,\$eauthor.

1 = Surname with no birth and death year and he wrote and narrated book

-ex 3. =100 1\ \$aRansom, James,\$eauthor,\$enarrator.

It is **not** a repeatable field

Only capitalize the first word in the title and proper names.

1st indicator

0 = Use when 1XX field is not present in the record

1 = Use when 1XX field is present

The 2nd indicator is very important in this field as it can keep an item from being located in the database.

2nd indicator (the number of character positions associated with a definite or indefinite article (i.e. a, an, the, le, la, or les) and the space after it.

-ex: =245 _0\$aAlexander and the terrible, horrible, no good, very bad day

-ex: =245 _2\$aA wonderful stroke of luck

-ex: =245 _3\$aAn affair of poisons

-ex: =245 _4\$aThe tinderbox

-ex: =245 _4\$aLes misérables

Subfield a (**\$a**) contains the title as it is seen on the disc

Subfield b (**\$b**) contains the remainder of the title as seen on the disc or container.

If there is a subtitle on the container and on the book record, but not on the disc, include the subtitle and a 500 note.

-ex: =500 \\\$aSubtitle from container.

If the book record includes a subtitle, but there is not one on the container or disc, include the subtitle and use a 500 note.

-ex: =500 \\\$aSubtitle from book record.

If there is a 490 and 8XX field for the series. Do not use the subfield b in the 245 field

Container says "A Stephanie Plum novel". No subfield b. 490 and 8XX fields should be present.

245 __ \$a Title Statement (continued)

Subfield c (**\$c**) is the statement of responsibility. It contains the author's name as seen on the disc. If there are multiple authors present, a cataloger can choose to use only the first author and add "[and others]" or "[and 5 others]" after the first author.

When "a novel by" is on the disc or container and right above the author's name, then the whole statement "a novel by James Smith" is placed in the **\$c** and **NOT** in **\$b**

-ex: =245 _0\$aDon't ever look back*/\$ca mystery by Dan Friedman

246 __ \$a Varying Form of Title

It is a repeatable field

No ending punctuation unless it is literally in the title

Articles (the, an, and a) at the beginning of the title are not used

Indicators tell how it appears in the catalog and where the title comes from

1st indicator (note/added entry controller)

Most commonly used:

1 = note, added entry

3 = no note, added entry

2nd indicator (type of title)

Most commonly used:

Blank = no type specified

0 = portion of title from the 245 field

4 = cover title

8 = spine title

Ends with a period

-ex: =250 \ \ \$aUnabridged.

264 \1\$a Production, Publication, Distribution, Manufacture, and Copyright Notice

1st indicator is blank

2nd indicator is "1"

This information can be taken from anywhere on the item with order of preference:

1. Disc
2. Container
3. Outside the item and container.

264 \1\$a Production, Publication, Distribution, Manufacture, and Copyright Notice (continued)

Subfield a (**\$a**) – Place of production, distribution, or manufacture, transcribed as it appears on the disc or container

Every effort is made to determine a place of publication, if not on the item, then by an internet search. When information is found outside of the item, then the information will be bracketed.

As a last resort, [Place of publication not identified] can be used when you can't find any place of publication information. Add a 590 field to explain where the information was derived.

In the fixed field “**Ctry**” box of the 008 grid, you will type “**xx**”.

-ex: 1\$a[Los Angeles, CA]*;\$bVisiona Romantica, Inc.;\$c2016

-ex: 590\$aPlace of publication taken from Worldcat

Subfield b (**\$b**) – Name of production, distribution, or manufacture, transcribed as it appears on the disc or container.

[publisher not identified] can be used if you are are unable to find any information online

Subfield c (**\$c**) – Date of production, distribution or manufacture

[date of publication not identified] can be used if you are are unable to find any information online

The date is taken from the disc surface and is preceded by ©. This is usually the same as the copyright date, but not always. If the copyright date is different, record the copyright date in the 046 field with a subfield “k”.

Date should not be in [brackets], unless the date is not on the item and is being taken from another source. A 590 note would be added listing where the date came from.

-ex: =264 \ 1\$a[United States]*;\$bTantor;\$c2015.

264 \1\$a Production, Publication, Distribution, Manufacture, and Copyright Notice (continued)

The date is taken from the disc surface and is preceded by ©. This is usually the same as the copyright date, but not always. If the copyright date is different, record the copyright date in the 046 field with a subfield “k”.

1st indicator is “1”

2nd indicator is blank

Needs to match book record

How to determine a series name: Search the local database first to see how the majority of the book series have been handled, then follow the same wording. You will need to look at the MARC record 490 field to see how it has been typed.

A local 590 note should be used to clarify where the cataloger got their series name and/or number if it is not on the book.

-ex: =590 \ \ \$aSeries name and number from KDL What's Next.

Volumes 1-9 should be listed as 01, 02, 03, etc.

No punctuation at the end of **\$v**

Requires either 800 **or** 830 field

No articles (A, An, The) at the beginning of subfield a (**\$a**)

No descriptive after the character's name (novel, mystery, novels, etc.) in subfield a (**\$a**)

If the volume/series number is not contained within the book, but you find it from another source (i.e. NoveList, KDL What's Next, Fantastic fiction, author's website), add a 590 field with "Series name and number from"

Series about a character follows the format example below:

-ex: =490 1*\$a***Harry Potter****;***\$v***02**

A main series with a subseries follows the format below:

-ex: =490 1*\$a***I can read! My first shared reading**

-ex: =490 1*\$a***Warriors. Dawn of the clans****;***\$v***03**

If multiple series volumes are combined in one book, each series number will be on a separate 490 line and 8XX line. Example "A lineage of grace" by Francine Rivers has 5 volumes in one book. The MARC record should have five 490 fields and 8XX fields.

Enhanced formatted contents notes¹

There should only be 1 summary, keep the longest one if there are more than one

Summaries do not have to be in quotation marks. A summary may be derived from the item or a reputable source such as Worldcat, NoveList, author's website. A review from Library Journal, Publisher's Weekly, School Library Journal, Booklist is acceptable to use. Please note in \$c where the review came from.

-ex. --\$cfrom NoveList!

However, a customer review from Amazon reflects a personal opinion and is not objective, therefore, not usable as a summary.

If juvenile fiction, following the subject add: **\$v**Juvenile fiction.

If juvenile nonfiction, following the subject add: **\$v**Juvenile literature.
